4.1 License terms for Product related SenTec Software

4.1.1 LuMon[™] Monitor GUI Software

END-USER LICENSE AGREEMENT (EULA)

Please carefully read the following terms and conditions before using this Product. It contains SenTec Software, the use of which is licensed by SenTec AG, to its customers for their use only as set forth below. No part of the SenTec Software may be reproduced, copied, translated or transmitted in any form or by any means without the prior written permission of SenTec AG.

GRANT OF LICENSE:

SenTec AG (the "Licensor") grants to you this limited, non-exclusive, non-transferable, non-assignable license solely to use in a single copy of the SenTec Software on a single Product for use by a single concurrent user only and solely provided that you adhere to all of the terms and conditions of this EULA.

ASSENT: By entering into any purchase agreement for the Product or by installing the SenTec Software, you agree that this EULA is a legally binding and valid contract, agree to abide by all of the terms and conditions of this EULA, and further agree to take all necessary steps to ensure that the terms and conditions of this EULA are not violated by any person or entity under your control or in your service.

RESTRICTIONS:

(a) To the extent allowable under the applicable law, you are expressly prohibited from copying, modifying, altering, adapting, porting, merging, selling, leasing, redistributing, assigning, or transferring in any matter, SenTec Software or any portion thereof.

(b) You may take a single copy of materials within the package or otherwise related to SenTec Software only as required for backup purposes.

(c) To the extent allowable under the applicable law, you are also expressly prohibited from reverse engineering, decompiling, translating, disassembling, deciphering, decrypting, or otherwise attempting to discover the source code of the SenTec Software as the SenTec Software contains proprietary material of Licensor.

TERM:

2. ADDITIONAL LICENSING REQUIREMENTS AND/OR USE RIGHTS

- **a. Specific Use.** SenTec AG designed the device for a specific use. You may only use the software for that use.
- **b. Other Software.** You may use other programs with the software as long as the other programs
 - directly supports the manufacturer's specific use for the device, or
 - provide system utilities, resource management, or anti-virus or similar protection.
 - Software that provides consumer or business tasks or processes may not be run on the device. This includes email, word processing, spreadsheet, database, scheduling and personal finance software. The device may use terminal services protocols to access such software running on a server.
- **c. Device Connections.** You may not use the software as server software. In other words, more than one device may not access, display, run, share or use the software at the same time.
