# **Emissions reduction targets**

Sentec Medical Ltd has begun its journey to net Zero in 2050 with the creation of our first CRP. However,  $CO_2$  emissions are already of concern to our business. Sentec has a management system in place, which helps to reduce the environmental impact of each employee. Business travel is reduced to a minimum. When business travel is necessary, public transport is the preferred means of travel. In addition, Sentec covers the costs of public transport for all employees and encourages use of electric vehicles by employees.

In order to achieve Net Zero, we will adopt carbon reduction targets guided by our CRP analysis.

We project that carbon emissions will decrease over the next five years by 20%.
